The Customer

The client is a multinational oil and gas company with operations across five continents. Although the company is a major player in all aspects of the energy sector, its main business is the exploration and extraction of natural gas and oil and the production of liquefied natural gas, which is sold to wholesale customers such as retail gas suppliers and electricity generating companies.

The Challenge

The natural gas exploration and production industry relies heavily upon emails and large attachments that address a wide variety of commercially-sensitive issues, including surveys, projected productions, financials, legal responsibilities and implications, etc. As with all major organisations, the company was increasingly concerned
